The request comes to the city for 94.534 acres more or less tract of land in the Rolly P. Covington Survey, Abstract 148, tract 2. The request is from Agriculture to SF-E (Single Family Estate). (Ordinance No. 2020-616)

Cheryl McClain – updated the council and citizens on the zoning request and that the Planning & Zoning commission recommended approval at their meeting on July 20th it was recommend in favor from the P&Z board.

staff sees no adverse impact to the surrounding area. It does come to the council from the P&Z board with a favorable recommendation.
